We sincerely hope this plan provides you with a viable alternative.

This is **NOT** dental insurance. Enrolling in our program gives you the opportunity to obtain your dental treatment exclusively at our practice for reduced fees. It cannot be combined with dental insurance or any other reduced fee dental plans.

## Membership Information and Benefits:

- All memberships include these annual benefits: 2 periodic examinations, 2 simple cleanings or periodontal maintenance visits with fluoride treatments, 1 emergency exam with periapical x-ray (if necessary), and at least 20% savings on other treatment(s) provided.
- Annual membership rates are as follows: Individual: \$389 (a \$614 value); Spouse or children between 12-18 years (23 years if enrolled in college): \$349 (a \$614 value); Children under 12 years: \$329 (a \$544 value).
- 10% discount on subsequent annual enrollment with "automatic renewal"
- No deductibles, no waiting periods, no exclusions on treatment, no coverage limits
- No issues with pre-existing dental conditions
- No insurance claims to submit; No pre-authorizations required

## Discounts on Treatment In Addition to Basic Membership Benefits:

- Sealants: 50% discount
- Night Guards and Orthodontic Retainers: 35% discount
- Take home bleaching trays and bleach refills: 30% discount
- Space Maintainers: 30% discount
- Surgical Extractions: 30% discount
- Regular Extractions: 25% discount
- All other treatment: 20% discount

## LIMITATIONS AND EXCLUSIONS

- Annual enrollment fees are due at time of enrollment
- No refunds given if patient does not utilize program benefits for the year
- Program cannot be used for treatment already in progress
- Benefits do not transfer from one member to another
- Benefits do not carry over to the following year if not used
- If patients move or want to discontinue program before the end of the term, refunds will be at the sole discretion of the provider
- This is NOT an insurance program, and it cannot be used in conjunction with any other offer or any dental insurance
- This plan is only honored at Willow Creek Family Dentistry; therefore, if your treatment requires a referral to a specialist, they will not offer this discount
- Should there be any treatment needed following an injury where a lawsuit is involved (ie. Medical care, disability, workman's comp, etc.), this plan cannot be used
- Payments for services are due at time of service to receive the discounted rate. If you choose to extend your payment for treatment through a third party finance company (ie. CareCredit, CitiHealth), the discount will be reduced by 10% due to merchant fees and administrative costs
- Plan is subject to change annually; however, your agreement will be honored for the full year of your individual enrollment
- All fees shall be based on our usual and customary fee schedule and not upon any other dental plan's fees
